

## EARLY ATTENTION AREA



#### POPULATION SERVED:

**98** Girls and boys from newborn to 6 years old.

#### **OBJECTIVE:**

To address the temporary or permanent needs of children from birth to 5 years 11 months of age in order to prevent a specific problem, avoid potential harm, and develop skills that enhance their neuromotor development.

### SCHOOL INCLUSION AREA

#### POPULATION SERVED:

**83** girls, boys and adolescents aged 5 to 16 who attend regular schools (preschool, primary, secondary).

#### **OBJECTIVE:**

To encourage children and adolescents with disabilities and/or special educational needs to develop and strengthen functional learning that enables inclusion and retention in regular school in their community.

In 2024, **38 children were evaluated** for the first time in the School Inclusion Area in **105 sessions**. Each parent received an initial assessment and received advice on their therapeutic and clinical follow-up.

#### PRE-EMPLOYMENT TRAINING AND INDEPENDENT LIVING AREA

#### **POPULATION SERVED:**

29 children, girls and adolescents.

#### **OBJECTIVE:**

To help children and adolescents with disabilities and/or special educational needs develop autonomy and independence in various life activities and acquire and strengthen work habits to generate changes in attitudes among themselves and their families.










#### **MUNICIPALITIES OF ORIGIN**


#### **SOCIOECONOMIC LEVEL**




